

RESOLUTION NO 15-2016

A RESOLUTION PROVIDING FOR A SALARY INCREASE FOR FERGUS COUNTY ELECTED OFFICIALS FOR THE FISCAL YEAR COMMENCING ON JULY 1, 2016

WHEREAS, the Board of Commissioners of Fergus County has met with, received input from, and been provided with a wage and benefit proposal by a committee comprised of elected officials of Fergus County; and

WHEREAS, the Board of Commissioners, with Fergus County being a charter form of government, has discretion to fix salaries, wages, and benefits for all Fergus County employees and elected officials; and

WHEREAS, the proposal submitted to the Board by the committee of elected officials is a reasonable proposal;

NOW THEREFORE, BE IT RESOLVED, that for the fiscal year commencing on July 1, 2016, the Board sets the salaries for Fergus County Elected Officials as follows:


