

RESOLUTION NO. 13-2016

**A RESOLUTION APPROVING THE ANNEXATION OF REAL PROPERTY
INTO THE LEWISTOWN RURAL FIRE DISTRICT OF FERGUS COUNTY
FROM THE CHEADLE RURAL FIRE DISTRICT**

WHEREAS, there is a Rural Fire District in Fergus County known as the Lewistown Rural Fire District; and the boundaries of such district adjoin the Cheadle Rural Fire District; and

WHEREAS, the Board of Trustees of the Cheadle Rural Fire District have approved of the annexation of real property from their Fire District into the Lewistown Rural Fire District; upon written Petition of the land owners; and the property proposed to be annexed to the Lewistown Rural Fire District is described as follows:

East of Lewistown, on or near the divide; in sections 10, 11, 12, 13, 14, 15, 22, 23, 24, and 25, in Township 15N, Range 19E; and in sections 6, 7, 18, 19, and 30 in Township 15N, Range 20 E; as shown on the attached map. The map also shows the landowners affected.

WHEREAS, pursuant to Section 7-33-215, Montana Code Annotated, the Board of Commissioners have caused notice to be published regarding the petition; such notice having been published on the 6th day of August, and the 13th day of August, 2016; and


WHEREAS, on the 17th day of August, 2016, this matter came before the Board of Commissioners for a public hearing and the Board heard comment on such annexation, and there was no protest petition presented; and at the close of comment, the Board approved the annexation;

NOW THEREFORE BE IT RESOLVED that the real property described above is hereby approved for annexation into the Lewistown Rural Fire District; such annexation being effective on the 17th day of August, 2016; and

BE IT FURTHER RESOLVED that the Fergus County Clerk and Recorder is hereby directed to provide a true and correct copy of this resolution, to the local office of the Department of Revenue, and to the trustees of the Lewistown Rural Fire District and the Cheadle Rural Fire District.
