

RESOLUTION NO. 3803 3-2013

A JOINT RESOLUTION ADOPTING AND APPROVING BYLAWS FOR THE LEWISTOWN AIRPORT BOARD, PROVIDING FOR AN EFFECTIVE DATE, AFFIRMING THE EXISTENCE OF THE JOINT AIRPORT BOARD, AND REPEALING ANY PRIOR RULE OR POLICY CONTRARY TO THE BY-LAWS ATTACHED HERETO AND MADE EFFECTIVE HEREIN

WHEREAS, Fergus County is a joint owner, with the City of Lewistown, of the Lewistown Municipal Airport property, and as a co-owner is interested in the efficient and orderly administration of the airport property through the Lewistown Airport Board; and

WHEREAS, a Joint Resolution, number 5-98, was passed by the Board of Commissioners of Fergus County, and the Commission of the City of Lewistown, on or about March 18, 1998, and such resolution provided for the creation of a joint airport board under the provisions of the Municipal Airports Act, found in Title 67, Chapter 10, Montana Code Annotated; and

WHEREAS, at this time the Airport Board has approved and submitted a document entitled "Lewistown Municipal Airport Bylaws", and the Airport Board has requested the approval of both governing bodies; and such approval from both governing bodies is required by the Joint Resolution referred to above; and

WHEREAS, both the Board of Commissioners of Fergus County and the Lewistown City Commission have duly considered the attached

document, the "Lewistown Municipal Airport Bylaws; and find such bylaws to be appropriate and necessary for the efficient and orderly administration of the Lewistown Municipal Airport;

NOW THEREFORE BE IT RESOLVED, that the attached document, entitled "Lewistown Municipal Airport Bylaws" is hereby approved and shall be the bylaws of the Airport Board from the effective date; and

BE IT FURTHER RESOLVED, that duplicate originals of this document and its attachment shall be maintained; one such original by the City Clerk, and one such original by the Fergus County Clerk and Recorder, both of whom will distribute copies hereof to any interested party or citizen;

BE IT FURTHER RESOLVED that this Joint Resolution shall become effective upon passage and approval by both the Fergus County Board of Commissioners and the Lewistown City Commission; and


BE IT FURTHER RESOLVED that both Commissions expressly declare their intention to affirm the continued existence of a Joint Airport Board; which was established, recognized, and formed pursuant to the Municipal Airports Act in Joint Resolution No. 5-98, passed by both Commissions on or about March 18, 1998; and

BE IT FURTHER RESOLVED that any provision of the Joint Resolution referred to herein which conflicts with any provision of the attached Lewistown Municipal Airport Bylaws is hereby repealed.
