Minutes of Fergus Co. Commissioners Special Business Meeting September 1, 2017 – 10:00 a.m. Fergus County Commissioners 712 W. Main St., Suite 210 - Lewistown, MT 59457

Present: Presiding Officer Carl Seilstad, Commissioner Sandra Youngbauer, Commissioner Ross Butcher, and Clerk & Recorder Rana Wichman. Public present: See attached sign in sheet.

CALL TO ORDER:

Presiding Officer Seilstad called the meeting to order at 10:00 a.m.

PUBLIC COMMENT ON AGENDA ITEMS: None

PUBLIC HEARING:

1) Final Budget Hearing: Presiding Officer Seilstad opened the final budget hearing. He stated that the FY1718 levied fund final budget is \$12,159,168. With this budget the County is at a maximum 33% cash reserve for most levied funds with the exception of pass through funds. In FY1516 the levied fund final budget was around \$10,994,000 with an average of 22% to 23% cash reserves, and in FY1617 the budget was around \$11,766,000 with cash reserves increased but still only around 30%. Fergus County is in excellent shape financially. Cash available has increased. Seilstad also reported that non-levied fund budgets are up about \$1.8 million mostly due to an airport runway reconstruct project being funded with an FAA grant plus a 10% local match. Mills levied for health insurance are down 2.25 mills. Commissioner Butcher said the County looks good, partially due to conservative payment of approximately one-half of the intercap loans. Commissioner Youngbauer feels Fergus County has come a long way. We are utilizing our capital improvement plan including upgrading some road equipment. At this point Commissioner Seilstad closed the public hearing.

 - b) Elected Official Salary Resolution: This will be postponed until the September 11, 2017 meeting.
