CALL TO ORDER:

Commissioner Ross Butcher called the meeting to order at 2:00 p.m.

APPROVAL OF MINUTES:

Commissioner Butcher asked if there were any alterations or corrections to the March 20, 2019 minutes. Hearing none he stated the minutes will stand approved as presented and will be on file with the Clerk and Recorder and on the Fergus County Website.

PUBLIC COMMENT ON AGENDA ITEMS:

Peggy Butler asked to discuss the SAFE program at this point since there was no action to be taken. She discussed the fact that Fergus County has no shelter or pound for animals. She asked if there is any land that the County owns that could be used for this purpose. There was discussion regarding whether this could work in conjunction with the Farm in the Dell at the poor farm. There will be a spay and neuter clinic on May 10, 2019. The charge for this is \$350.00 per day. She asked if the County could consider helping fund this. Commissioner Seilstad indicated he will look at the properties owned by the County and also at whether there are funds available to help with the clinic.

DISCUSSION / ACTION ITEMS:

- 1) March 25, 2019 Claims: Commissioner Seilstad moved to approve the March 25, 2019 claims as presented. Commissioner Youngbauer seconded. Passed unanimously.
- 2) Coroner Funeral Home Rotation and RFI: Commissioner Youngbauer moved to approve the Coroner Solicitation of Interest as presented to get it to the discussion phase. Commissioner Seilstad seconded. Commissioner Seilstad stated that the prices on the Solicitation of Interest that was presented to the Commissioners for this meeting are not what was discussed in the meeting where it was developed. Sheriff/Coroner Rick Vaughn stated he doesn't want to charge too little or there won't be any interest shown. Commissioner Seilstad said they had agreed on \$200.00 for a secure pickup and transportation day or night within Fergus County rather than the \$250.00 in the document presented today. The \$100.00 per 24-hour period of secure storage is only to be paid after the first 24 hours when there is a coroner investigation required. There should not be a charge for collecting samples for analysis as we should be providing any supplies needed. Vaughn said he was looking at the budget and feels the numbers presented would work. Seilstad told him you can't look at the current budget because it is only for half a year and was padded due to the uncertainty of how things would work. Vaughn said the way it is set up Fergus County will need a chiller and a way to transport. Commissioner Butcher stated we don't need a chiller if we are loading and shipping. This discussion only involves those bodies where a funeral home isn't designated. At this point Commissioner Youngbauer moved to work with the Solicitation of Interest that was presented with the following changes: 1) Replace \$250.00 with \$200.00 for secure pickup and transportation of human remains within Fergus County any time of day or night. 2) Pay \$100 per 24-hour period of storage after the first 24 hours. 3) No fee will be paid for the collection of a biological sample. 4) \$250.00 will be paid for the transporting of human remains to Billings or other locations for autopsies. Discussion on this motion included that Fergus County will need to provide kits for collecting samples including syringes. Motion passed unanimously. At this point the original motion that was made to bring the topic to discussion was voted on and failed.
- 3) Public Safety Budget Amendment Resolution: Commissioner Seilstad made a motion to approve Resolution 4-2019 which is a Public Safety Budget Amendment for funds received from insurance on a sheriff's vehicle that was in an accident. Commissioner Youngbauer seconded. Passed unanimously.
- 4) SAFE Program (Save Animals from Euthanasia) see Public Comment on Agenda Items.

Solicitation of Interest

Notice is hereby given that Fergus County is seeking interested parties to provide secure transportation, storage, and assistance with examination of human remains that are subject to coroner investigations. Fergus County may enter a contract for these services with one entity or establish a rotation system with multiple entities.

The services required are:

- (1) Secure pickup and transportation of human remains within Fergus County any time of day or night. Must have ability to be in route to a scene from within Fergus County within thirty (30) minutes of being dispatched. A reliable vehicle with a lockable, enclosed, air-conditioned cargo area; a gurney; and personal protective equipment are required. Fergus County is offering to pay \$200 per trip.
- (2) Secure storage of human remains pending a coroner's investigation. A lockable refrigeration unit is required. Fergus County is offering to pay \$100 per 24-hour period of storage after the first 24-hours.
- (3) Secure facilities to examine remains and collect biological samples for analysis.
- (4) Transport of human remains to Billings or other locations for autopsies. Fergus County is offering to pay \$250 per trip.

Anyone conducting transports must have a valid Montana driver's license and approved insurance. Anyone with access to human remains that are in coroner custody may be required to pass a background check.

Witten letters of interest must be received by Becki Wiseman, 712 W. Main St., Ste. 208, Lewistown, MT, 59457, no later than 5 p.m. on April 8, 2019. Proposals must be placed in sealed manila envelope. The following information shall be written or typed on the outside of the envelope: (1) the name, address, and telephone number of the entity submitting the proposal, and (2) the words "Proposal for pickup, transportation, and storage."
