OTHER BUSINESS:

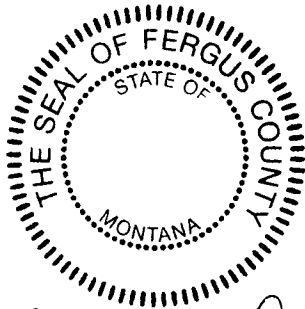




