The Sheriff's office currently is using Hanser's Towing for any vehicles they need picked up and they do all the paperwork. Commissioners advised there is no language stating who the Sheriff's office has to use. It was discussed that the Sheriff's office will use both the Junk Vehicle program and Hanser's Towing. **Motion Passed.**
2. Commissioner Seilstad moved to approve **Resolution 5 – 11**, interlocal agreements between the Fergus County joint recycling district and vehicle recycling program and Petroleum, Musselshell, Judith Basin, Golden Valley, Wheatland, Garfield, & Meagher County's respectively. Each agreement says the same thing for each county. Commissioner Butcher 2<sup>nd</sup>; **Motion Passed.** Clerk Tucek will send each county their FC Commissioner signed agreement for them to pass, sign and return.




